

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: Regarding grant of permission to Bharatesh Homeopathy Medical College and Hospital Belgaum, for enhancement of the number of admissions to the B H M S Course, from 50 to 100, from the academic year 2002-2003.

PREAMBLE:

Vide letter dated: 4.9.2002 of the Secretary Central Council of Homeopathy New Delhi, cited at read (1) above, permission is accorded to the Bharatesh Homeopathy Medical College and Hospital Belgaum, to enhance BHMS course seats, for the year 2002-2003, subject to improvement of the facilities at the college.

Vide his letter cited at Read (2) above, the Chancellor, Rajeev Gandhi Health Sciences University Bangalore, has recommended affiliation for the enhancement of admissions from 50 to 100 to Bharatesh Homeopathy Medical College and Hospital Belgaum, for the BHMS course, from the academic year 2002-2003.

Vide representations cited at Read (3) above, the Dean, Bharatesh Homeopathy Medical College and Hospital Belgaum, while enclosing letter dated: 4.9.2002 of the Secretary, Central Council of Homeopathy New Delhi and letter dated: 31.3.2003 of the Rajeev Gandhi Health Sciences University Bangalore, has requested for enhancement of seats at his institution from 50 to 100 for the BHMS course from the year 2002-2003.

Exercising the powers conferred under Article 45 (10) (B) of the Rajeev Gandhi Health University Act 1994, recommendation of coordination is made for the enhancement of the limitation of admissions for the BHMS course from 50 to 100 (50 seats) from the academic year 2002-2003 to Bharatesh Homeopathy Medical College and Hospital Belgaum, subject to fulfillment of the below mentioned conditions:

- 1) To maintain high standard of quality education prescribed by the Central Council of Homeopathy and to provide the prescribed facilities.
- 2) The institution shall communicate and transact with the Central Council of Homeopathy through concerned competent authority.
- 3) To fulfill conditions prescribed by the Rajeev Gandhi Health Sciences University.
- 4) No grant in aid and facility whatsoever of the government, shall be rendered for the said course and college.
- 5) The said institution is bound by the rules in force, concerning allotment of government seats in respect of avenues of admissions.

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: Regarding grant of permission to the Bharatesh Homeopathic Medical College and Hospital, Belgaum for enhancement of seats at the Postgraduate courses- from 3 to 6 in Metria Medica, 3 to 6 seats in the Organon and Homeopathic Philosophy and 3 to 6 seats in the Homeopathic Reprotary and Case Taking, from the year 2001-2002.

Read: (1) Letter Number 19-5/2001-CCH-4373, dated: 11.5.2001 of the Central Council of Homeopathy, New Delhi.

(2) Notification dated: 2.6.2001 of the Chancellor, Rajeev Gandhi Health Sciences University Bangalore.

(3) Letter dated: 8.11.2004 of the Dean, Bharatesh Homeopathic Medical College and Hospital Belgaum.

PREAMBLE: Vide letter dated 11.5.2001 of the Central Council of Homeopathy, New Delhi, cited under reference (1) above, permission is granted to the Bharatesh Homeopathic Medical College and Hospital Belgaum i.e. 6 pupils are permitted into the postgraduate course subjects of Homeopathic Metria Medica, Homeopathic Philosophy and Reprotary, from the years 2001-2002 and 2002-2003.

Vide letter dated: 2.6.2001 of the Chancellor, Rajeev Gandhi Health Sciences University Bangalore, cited under reference (2) above, permission is granted for the coordination of (1) 3 to 6 seats for the Homeopathic Metria Medica, (2) 6 seats for the Organon and Homeopathic Philosophy, and (3) 6 seats for the Homeopathic Reprotary and Case Taking, into the M.D. Homeopathy courses, newly, from the year 2001-2002.

Vide letter dated: 8.11.2004 cited under reference (3) above, the Dean, Bharatesh Homeopathic Medical College and Hospital Belgaum, has submitted a representation to the government stating that 6 seats are permitted in each of the 3 subjects of the M.D. Homeopathy Postgraduate courses viz. (1) Homeopathic Metria Medica, (2) Organon of Homeopathic Philosophy, and (3) Homeopathic Reprotary and Case Taking. In this respect the Rajeev Gandhi Health Sciences University Bangalore has recommended permission for coordination of 6 seats in each of the subjects. Similarly, the government also has, under order number AA.KU.KA 249 PIM 99, dated: 23.5.2000 has accorded permission already for the commencement of each subject with 3 seats. It is now requested for grant of permission for 3 seats in each of the subjects from the year 2001-2002 i.e. a total number of 6 seats in each of the subjects.

Exercising the powers conferred under Article 45 (10) (B) of the Rajeev Gandhi Health University Act 1994, sanction of recommendation is accorded for the enhancement of seats from 3 to 6 (3 seats) at the post graduate courses of: (1) Homeopathic Materia Medica- 3 to 6 (3 seats), (2) Organon and Homeopathic Philosophy- 3 to 6 (3 seats), (3) Homeopathic Repertory and Case Taking- 3 to 6 (3 seats), in respect of coordination, to Bharatesh Homeopathic Medical College and Hospital, Belgaum from the year 2001-2002, subject to fulfillment of the below noted conditions:

- 1) The institution shall be bound by the government prescribed number of admission of students. If more number of students is admitted than the prescribed number, the concerned institution shall be held responsible.
- 2) The least facilities prescribed by Central Council of Homeopathy, New Delhi, shall be maintained.
- 3) No grant in aid or facility whatsoever is provided by the government to the concerned colleges running the said courses.
- 4) Permission of the Ministry of Health and Family Welfare, Ayush Department, New Delhi shall be obtained.
